4. 符合首航之郵輪者，碼頭碇泊費將逕予免收；符合特定港口(臺北、臺中、安平、蘇澳、花蓮)旅客服務費全免優惠、高雄母港優惠者旅客服務費逕予減免或免收。
5. 符合一程多港碼頭碇泊費全免、旅客服務費航次累計優惠、鼓勵增加外籍旅客優惠，由航商業者或船務代理公司主動向各分公司提具相關佐證資料申請免收或退費事宜。
6. 同一國際郵輪適用高雄母港優惠之郵輪航次，不再列入旅客服務費航次累積航次優惠之統計。
7. 鼓勵增加外籍旅客優惠可與其它旅客服務費優惠合併使用，惟以該航次旅客服務費折免完畢為上限，恕不得請求退還、折換現金、折免其它航次費用或累計至下一年次折抵。
8. 本優惠措施中，碼頭碇泊費或旅客服務費優惠以單一航次折免完畢為上限，不得請求退還、折換現金、折免其它航次費用或累計至下一年次折抵。

1. Effective from January 1st, 2025 until December 31th, 2025 determined by ship's ATD (Actual Time of Departure.)
2. The port of calls shall be calculated by each cruise ship separately.
3. The term, passenger service charge, is charged by total actual number of embarked passengers.
4. Once cruise ship meets "maiden voyage" incentive terms and conditions of Free Dockage, the charge will be waived directly without application. Once cruise ship meets incentive terms and conditions of Free Passenger Service Charge, Kaohsiung Homeport Incentives, the charge will be waived or reduced directly without application.
5. Once cruise ship meets "Multiple port of calls" incentive terms and conditions of Free Dockage, reaches the target of Passenger Service Charges accumulated number of calls at the same port in 2025 or Incentives to increase the number of foreign passengers, cruise company or shipping agent shall take the initiative and apply to each branch of TIPC for the discount refund or reduced with supporting documentation.
6. Voyages on the same cruise ship that qualify for the Kaohsiung homeport Incentives will no longer be counted towards the 50% discount on Passenger Service Charge for accumulated number of Calls.

7. The incentive to increase the number of foreign passengers may be combined with other Passenger Service Charge incentives. However, it is limited to the reduction until full waiver of Passenger Service Charge for the applicable voyage. Refunds, cash conversions, application of the discount to other voyages, or carrying over the discount to the following year are not permitted.
8. The incentive for Dockage Fees or Passenger Service Charges is limited to the reduction until full waiver for a single voyage. Refunds, cash conversions, applying the discount to other voyages, or carrying over the discount to the following year are not permitted.
9. Amounts of the scheme is in New Taiwanese Dollars and shall be rounded to the nearest whole number.
10. In case of unsettled matters, TIPC reserves the right of final decision.
